RATES & FARES

Prices are provided as a guide only and may vary due to currency fluctuations beyond our control. Total price of the tour is not guaranteed until payment in full has been received. All rates advertised are accurate at the time of publication and are subject to change until received of payment in full. AYM Golf Tours Pty Ltd reserves the right to adjust our tour cost if necessary.

AIRFARES:

A number of Domestic and International airfares can be used in conjunction with your golf holiday package. All airfares are subject to availability and special conditions may apply.

PAYMENT

- A\$1000.00 per person deposit is required when you make a booking.
- Final payment is required on 1 June 2010.

If for any reason your balance is not received by us by the due date, we reserve the right to treat your booking as cancelled and to apply the appropriate you will forfeit previous payments and may be subject to cancellation fees.

AMENDMENTS:

There will be AUD\$50.00 amendment fee each time to amend a booking.

CANCELLATION FEES:

There will be a minimum charge of \$AUD200.00 for any cancellation to cover administration cost.

- Within 100 days before the departure date-AUD\$600.00
- Within 28 days before the departure date – 50% of the total price of the services.
- Within 7 days before the departure date – 100% of the total price of the services.

All refunds are subject to us receiving the funds from the relevant supplier.
